TERMS AND CONDITIONS

The purpose of this document is to set out the terms and conditions and the financial and operational terms for the participation of any company or organization (hereinafter referred to as the Exhibitor) wishing to take part in the trade exhibition SARA 2017 (hereinafter referred to as the Exhibition). SARA 2017 is organized by the Voodoo Group (hereinafter referred to as the Organizer), which acts in this edition as Delegates under an organization delegation agreement signed with the Ministry of Agriculture of the State of Côte d'Ivoire.

1. REGISTRATION MODE

Companies are required to submit a completed and signed participation form. Only applications for participation submitted with the first mandatory payment are taken into consideration.

2. PAYMENT - DELAY

The payment of contractually due amounts may be made either by cheque or bank transfer payable to the organizer, periodically and under the terms hereafter:

- 50% at the booking time;

- 50% 30 days at the latest before the exhibition

Any amount due and unpaid by the deadline set out above shall be subject to the interest for delay at a rate equal to three times the rate of legal interest that will start the day after the due date on the invoice. In the event of recourse to a judicial officer by the Organizer for non-compliance with the aforementioned settlement periods, the Exhibitor concerned shall pay a lump sum of 100 000 CFAF for recovery costs, in addition to the delays referred to above.

3. WITHDRAWAL

In case of withdrawal or in case of non-occupation of the stand for one reason or another, amounts paid in respect of the renting of the stand shall be the organizer's even in case the stand is rent out again to another exhibitor, after the first tenant's withdrawal.

4. ACCESS TO EXHIBITION

Access to the stands of the persons designated by the exhibitors is subject to mandatory wearing a personalized badge and/or a sticker made by the organizer.

The handing-over of badges and stickers to participants will take place when making full payment of the stand renting cost.

A badge of access is offered by the organizer on the basis of a badge for three square meters of stand rented. However, this allowance may not exceed ten badges per stand regardless of the area rented.

5. STANDS ASSEMBLY AND DISMANTLEMENT DATE

Stand assembly operations are scheduled for October 2017. The assembly of the stands must be fully completed 3 days before the opening of the Exhibition. The displaying of the exhibited products must take place on the eve of the opening of the Exhibition no later than 12.00 am.

Dismantling of installations and removal of exhibited objects must be carried out from 27th to 30th November 2017 before 6 pm at the latest.

6. CLEANING, MAINTENANCE AND SECURITY

The general maintenance of the aisles of the Exhibition, the security of the premises are ensured in outside opening hours by the organizer.

Each exhibitor is responsible for cleanliness and security in the perimeter of its stand.

7. CUSTOMS - LEGALITY

Each Exhibitor will carry out all the customs formalities applicable to equipment and products coming from abroad and intended for exhibition. The Organizer cannot be held liable for difficulties that might be encountered during those formalities.

Each exhibitor assumes full responsibility for the legality of the operations carried out in its stand during the Exhibition.

8. LOCATION CHANGE - STAND UTILIZATION

The organizer reserves the right to change the location of the stands and the management of exhibiting areas if necessary.

The Exhibitor is not allowed to make any publicity, in any form whatsoever, or exhibit products and/or services of companies other than those mentioned on the booking form.

Any breach of this commitment will result in the immediate payment, by the Exhibitor, of a penalty established for each additional company, according to the pay scale provided in the booking form.

9. APPLICATION OF THE CONDITIONS FOR PARTICIPATION

The organizer reserves the right to modify, in the interest of the exhibition, the provisions of the hereby terms and conditions.

By signing their application form, Exhibitors are committed to respecting the provisions of this regulation as well as any new instructions necessitated by particular circumstances.

Any breach of these provisions shall expose the author to the immediate, temporary or permanent exclusion, without being entitled to a refund or any compensation whatsoever.

10. INVITATIONS

Three invitations per square meter are offered by the organizer. Beyond that offer any additional invitation will be paid for.

Invitations may not be reproduced or sold again under penalty of being invalidated. To this end, the Organizer reserves the right to cancel the invitation badges for

fraudulent use: resale, reproduction, theft, etc.

11. SHOOTING / BRANDS

The exhibitor expressly, without remuneration, authorizes the Organizer and its subsidiaries to:

- make, if he wishes, photographs and/or films showing him and his team members, as well as the products exhibited on his stand.

- freely use those images on all types of media, in particular advertising ones, in Côte d'Ivoire as well as abroad and indefinitely.

- quote and reproduce its trademark, or its corporate name, as commercial reference for the purposes of its communication, on any media (in particular the Internet), both in Côte d'Ivoire and abroad, for a period of five years from the date of signature of this regulation.

12. ENTERTAINMENT

Exhibitors who plan a musical entertainment on their stand should inform the Organizer first.

Any musical entertainment will be allowed only after agreement of the Organizer, upon presentation of a specific project (material and sound source used, type of entertainment).

Failure to comply with these provisions may lead to power cut, without notice, on the stand of the transgressing Exhibitor who cannot claim compensation.

13. ADVERTISING

Any light or sound advertising shall be subject to prior written approval of the Organizer.

Where granted, the respect of the agreement shall be subject to the condition that advertising does not in any way constitute an embarrassment to the neighboring exhibitors, to traffic and, in general, to the good performance of the Exhibition.

Failure by the exhibitor to comply with any of the above conditions shall result in the withdrawal of its agreement by notification without notice.

The distribution of leaflets, vouchers and forms is strictly prohibited in the aisles, within and outside the premises.

14. PRODUCT AND SERVICE SAFETY

Exhibitors assume full responsibility for the conformity of the products or services exhibited subject to the applicable safety standards (download at www.sara.ci) and for any defects in the products or services.

15. DAMAGES

The Organizer shall not be liable for any damages caused by exhibitors to third parties, nor for loss, theft or destruction of materials and exhibited goods.

16. INSURANCE - WAIVER OF ANY RECOURSE

By its very participation, any exhibitor acknowledges having read the characteristics of the insurance policy taken out by the organizer and waives all claims against the organizer, its insurers, any other exhibitor or any other person involved in the organization of the exhibition on behalf of the above mentioned persons.

17. LIVESTOCK - NATURE, LIFE & FOREST CLUSTER

Livestock cluster: an animal box is offered outside the marquee, when buying stand. Terms and conditions apply.

Nature, life and forest cluster: a bare surface is offered outside the marquee for a green exhibition when buying a stand.

18. EXHIBITORS 'ACCESS TO THE EXHIBITION HANDBOOK
